Billing Forum 21/9

- Bill Validation Price mapping, about half way through the 2.5m tariff descriptors. Aiming to complete by February
- Billing dashboard
 - Accuracy
 - Charges disputes v refunds
 - Latency
- ECCs in flight change of band, OR looking for materiality evidence



Billing Forum 19/10

- ECCs can be amended in-flight without cancel and re-raise!
- TRCs a change to the charge band requires cancelling and re-raising
 - Due to impact on scheduled resource
- OR will look into SMC handling TRC cases which will allow them to suppress the cancellation charge



Pre-SMF - 11/10

- Priorities for group:
 - System Incidents and communications
 - Escalations still not clear and no apparent progress
- Named Engineer for T2R often needed for data centres, no facility at present
- Request for a standalone survey product when CP knows it is needed, without raising a complex order



Pre-SMF

- Openreach Twitter account Plusnet and BTC not happy. Needs more work/clarification from OR
- Premium Business Helpdesk:
 - CSP not reflecting process accurately
 - Best Practice Guide needed
 - CPs need to see what benefit is being offered over other services



SMF - 11/10

- FTTP: OR using micro-cables for FTTP work allowing cheaper/quicker connectivity. Aiming for 2m more FTTP connections by 2020.
- Service delivery
 - Workstack still high following lightening strikes
 - Repair 39,500. Provision 320,000
 - Missed appointments at 2.48%
- Propensity to Contact: looking at ways of pushing info to tracker sooner – general downward trend

SMF

- One Openreach: Internal programme to help improve escalations and queries process
 - Working across different teams to improve communication and provide more info to CPs
 - Currently provision only: 72% now resolved at first level, from 57% initially
- Case Management
 - New team looking at multiple repeats for MPF/SMPF. Managed End to end.
 - Looking at Multiple Customer Furthers next



CFPCG - 12/10

- Gfast
 - Technical trial coming to an end
 - Pilot planned to start in Jan 17
- Business FTTP and FOD:
 - targeting new builds and business parks. Will add 500mbps and 1gig products next year
 - FOD: slow speed areas special offer 75% discount on distance related charges
 - 18/2 offer extended to 31 March and for <10mbps (from 3mbps)</p>



CFPCG

- Charging VAT at point of supply.
 - Proposed introduction for SOGEA, but concerns about equivalence across existing products
- SPBE– new prices with effect from 1/1/17
- LR VDSL 2 proof of concepts (12 cabs)
 running successfully. 3rd area to be added and
 planning to expand to SMPF only areas for
 next phase.
- FTTC SIM1 withdrawal still planned for March



Industry Liaison Panel – 18/10

- View from UKCTA and BT Agilemedia
 - NGCS has led to a drop in 087 traffic
 - More use of 03
 - Access charge on low-rate PRS is a disincentive
- On 31 Oct, PpP relaunching as:

Phone-paid Services Authority – the regulator for content, goods and services charged to your phone



Digital Economy Bill

- Empower consumers and provide better connectivity so that everyone has access to broadband wherever they live
- Build a better infrastructure fit for the digital future
- Enable better public services using digital technologies
- Provide important protections for citizens from spam email and nuisance calls and protect children from online pornography



- Give every household a legal right to request fast broadband connection
- Give consumers and businesses better information about communication services, easier switching and compensation if things go wrong
- Cut the costs for new infrastructure and simplify planning rules
- Stronger enforcement of direct marketing laws, and civil penalties for online pornographers who do not verify the age of their customers
- Remove legal barriers to digital government while reinforcing data protection laws



- Meeting on 18 July reviewed proposals to introduce a twitter channel
- Analysis shows up to 35% of contacts to OR could be CP appropriate and will be referred to them.
 - General feeling CP name should not be tagged at this point
 - Suggestion from OR of being "conversational". CPs and OTA did not think appropriate
- Openreach dealing with CP relevant issues via quick response or complex response format
